

**FIRST ADDENDUM TO PROFESSIONAL SERVICES
RETENTION AGREEMENT

CONSENT TO ASSIGNMENT OF CONTRACT**

THIS FIRST ADDENDUM TO PROFESSIONAL SERVICES RETENTION AGREEMENT AND CONSENT OF ASSIGNMENT OF CONTRACT is for that Contract for Professional Services entered into on September 27, 2016, by and between the County of Siskiyou ("County") and William M. Abbott and the firm of ABBOTT & KINDERMANN, LLP, ("Contractor") and is entered into this __ day of May 2017.

WHEREAS, Abbott & Kindermann, LLP, has recently incorporated as Abbott & Kindermann, Inc.; and

WHEREAS, the parties desire that all rights, duties or obligations of Abbott & Kindermann, LLP, under the contract be assigned to Abbott & Kindermann, Inc.; and

WHEREAS, the contract requires the express written consent of the County for Contractor to assign the contract; and

WHEREAS, the cost of services to be provided under the contract is expected to soon exceed the amount payable under the contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the contract.

NOW, THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

County hereby consents to the assignment of all obligations, duties, liabilities, commitments and rights of Abbott & Kindermann, LLP, in and to the Professional Services Retention Agreement dated, September 27, 2016, by and between County and Abbott & Kindermann, LLP, ("Contract") to Abbott & Kindermann, Inc.

A copy of the Assignment of Contract is attached hereto. Assignee, Abbott & Kindermann, Inc., shall be substituted for Assignor, Abbott & Kindermann, LLP, and monies to be paid under the Contract shall be paid to Abbott & Kindermann, Inc.

Paragraph 3 of the Contract shall be amended to increase the compensation payable under the Contract by Sixty-five thousand dollars (\$65,000.00) to an amount not to exceed Ninety Thousand Dollars (\$90,000.00).


