

**SIXTH ADDENDUM TO CONTRACT FOR SERVICES
BY INDEPENDENT CONTRACTOR**

This SIXTH ADDENDUM is to that Contract executed on March 20, 2012, as amended by Addendums dated 8/6/2013, 6/10/2014, 5/12/2015, 6/14/16, and 1/17/17 between the County of Siskiyou ("County") and Kings View Corporation ("Contractor").

WHEREAS, the County chooses to extend the term of the Agreement; and

WHEREAS, the cost of services to be provided under the contract for Fiscal Year 2017-18 has changed; and

WHEREAS, the parties desire to incorporate this revised rate in the amount of compensation payable under the contract;

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

1. The first sentence of Paragraph 2.a "TERM" shall be amended to the following:

"This Agreement shall become effective on July 1, 2017 and shall continue in full force and effect until June 30, 2018, subject to earlier termination as provided in this Agreement."

2. Paragraph 3 "COMPENSATION" shall be amended to revise the following:

- a. The first sentence shall be replaced in its entirety with "Total compensation for the July 1, 2017 – June 30, 2018 term of this Sixth Addendum, as set forth in subsections 3.a, 3.b, 3.c, and 3.d has a not to exceed amount of ONE HUNDRED FIFTY-FIVE THOUSAND EIGHT HUNDRED ELEVEN AND 11/100 DOLLARS (\$155,811.11).
- b. Paragraph 3.b shall be amended to change the Annual Anasazi Software Version Rights and support as described in Exhibit C (attached) to a not to exceed amount of THIRTY-NINE THOUSAND FORTY-TWO AND 15/100 DOLLARS (\$39,042.15).
- c. Paragraph 3.c shall be amended to change the Electronic Health Record (EHR) System Support Annual Cost as described in Exhibit D (attached) to a not to exceed amount of ONE HUNDRED TEN THOUSAND ONE HUNDRED SIXTY-EIGHT AND 96/100 DOLLARS (\$110,168.96).
- d. Paragraph 3.d shall be amended to change the Onsite Implementation and Training Services as described in Exhibit E (attached) to a total cost not to exceed the amount of FIVE THOUSAND AND no/100 DOLLARS (\$5,000.00) during the July 1, 2017 – June 30, 2018 term.

e. Paragraph 3.e shall be deleted in its entirety and replaced by the following:

“COUNTY agrees to pay CONTRACTOR for services set forth in Exhibit F – DSM V – APA subscription, attached hereto and incorporated by reference herein. Payment of the Annual Cost (one year term equals \$1,600.00) amount will be due and payable on or before February 1, 2018.”

All other terms and conditions of the Contract, as amended, shall remain in full force and effect.

Total cost not to exceed \$5,000 during the July 1, 2017 – June 30, 2018 term of this SIXTH ADDENDUM to the Agreement.

- Daily per diem rate for food and lodging: \$ 170.00 per day, per staff/trainer
- Travel expenses at cost depending on mode of transportation. Contractor must submit original receipts for reimbursement of travel expenses.
