THIRD ADDENDUM TO CONTRACT FOR SERVICES BY INDEPENDENT CONTRACTOR

THIS THIRD ADDENDUM is to that Contract executed on July 12, 2016 between the County of Siskiyou Health and Human Services Agency (County) and Dr. John L. Schaeffer Inc., DBA California Telepsychiatrists (Contractor).

WHEREAS, the Contract expired on June 30, 2017 and services continued to be required after that date; and

WHEREAS, the parties desire to extend the term of the Contract; and WHEREAS, the parties desire to increase the rate of compensation payable under the contract.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph <u>1.01 Contract Term</u> of the Contract for Services shall be amended to extend the term of the contract through August 31, 2017.

Exhibit A, Section III, B, shall be deleted in its entirety and replaced with the following:

"B. Payment:

1) For all services provided on or after April 25, 2016 through June 30, 2016, County shall compensate Contractor FOUR THOUSAND FOUR HUNDRED AND FORTY DOLLARS (\$4,440.00) per week in return for contractor's provision of one or more qualified Telepsychiatry Providers with at least twenty-four (24) hours of available time per week to deliver Child and Adult Telepsychiatry services at County's request. In the event that Contractor, or its agents, request to provide less than twenty-four (24) hours of services in a given week during this time period and County agrees to said request, then County shall compensate Contractor at the rate of ONE HUNDRED EIGHTY-FIVE DOLLARS (\$185.00) per hour of services actually provided during said week in lieu of the weekly payment of FOUR THOUSAND FOUR HUNDRED AND FORTY DOLLARS (\$4,440.00).

Beginning July 1, 2016, County shall compensate Contractor FOUR THOUSAND SIX HUNDRED AND EIGHTY DOLLARS (\$4,680.00) per week in return for contractor's provision of one or more qualified Telepsychiatry Providers with at least twenty-four (24) hours of available time per week to deliver Child and Adult Telepsychiatry services at County's request. In the event that Contractor, or its agents, request to provide less than twenty-four (24) hours of services

in a given week during this time period and County agrees to said request, then County shall compensate Contractor at the rate of ONE HUNDRED NINETY-FIVE DOLLARS (\$195.00) per hour of services actually provided during said week in lieu of the weekly payment of FOUR THOUSAND SIX HUNDRED AND EIGHTY DOLLARS (\$4,680.00). County shall compensate Contractor at TWO HUNDRED FIVE DOLLARS (\$205.00) per hour for TAR review services. Contractor shall prorate charges if less than one hour is provided.

Beginning July 1, 2017, County shall compensate Contractor FOUR THOUSAND EIGHT HUNDRED TWENTY DOLLARS (\$4,820.00) per week in return for contractor's provision of one or more qualified Telepsychiatry Providers with at least twenty-four (24) hours of available time per week to deliver Child and Adult Telepsychiatry services at County's request. In the event that Contractor, or its agents, request to provide less than twenty-four (24) hours of services in a given week during this time period and County agrees to said request, then County shall compensate Contractor at the rate of TWO HUNDRED DOLLARS (\$200.00) per hour of services actually provided during said week in lieu of the weekly payment of FOUR THOUSAND EIGHT HUNDRED TWENTY DOLLARS (\$4,820.00). County shall compensate Contractor at TWO HUNDRED ELEVEN DOLLARS (\$211.00) per hour for TAR review services. Contractor shall prorate charges if less than one hour is provided.

- 2) The rate paid by County to Contractor is inclusive of all expenses incurred by Contractor while providing services pursuant to this agreement. County is not obligated to pay Contractor any additional sums for any expenses incurred by Contractor during the term of this agreement.
- 3) Contractor is not expected to bill any third-party payers, including Medicare, before requesting payment from the County. Contractor shall not seek payment from any other source and, shall, at no time, seek compensation directly from County's clients.
- 4) Upon request, Contractor shall provide County with required records for billing verification purposes, utilization review, and other purposes as provided by this agreement, and all records shall provide all information necessary for County to receive payment or reimbursement from Medi-Cal. County may delay or not pay compensation to Contractor if Contractor's records and/or the contents of those records are deficient or incomplete under Medi-Cal guidelines or in any delay or prevent County from receiving payment or reimbursement from Medi-Cal."

All other terms and condition	ons of the Contract shall remain in full force and
effect.
