

**FOURTH ADDENDUM TO CONTRACT FOR SERVICES  
BY INDEPENDENT CONTRACTOR**

THIS FOURTH ADDENDUM is to that Contract for Services entered into on October 7, 2014 by and between the County of Siskiyou ("County") and Restpadd Psychiatric Health Facility ("Contractor") and is entered into this 12<sup>th</sup> day of June, 2017.

WHEREAS, the parties desire to update the rates in Exhibit A, Section 2. Compensation and Billing: A, 1.

NOW, THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

The rates set forth in Exhibit A, Section 2: Compensation and Billing, A, 1 shall be amended as follows:

**"Fiscal Year 17/18**

Eight Hundred Eighty Dollars and No Cents (\$880.00) per client, per day for Indigent and Medi-Cal patients. Contractor will not charge for the client's day of discharge. An increase of \$20.00 from subsequent fiscal year.

An additional Four Hundred Dollars and No Cents (\$400.00) per client, per day for 1:1 individual care, not to exceed One Thousand Two Hundred Eighty Dollars and No Cents (\$1,280.00) per client, per day for Indigent and Medi-Cal patients. All such services are to be coordinated with County and prior approval shall be obtained from the Siskiyou County Health and Human Services Agency Director, Behavioral Health Division Director, or his or her designee.

**Fiscal Year 18/19**


Nine Hundred Dollars and No Cents (\$900.00) per client, per day for Indigent and Medi-Cal patients. Contractor will not charge for the client's day of discharge. An increase of \$20.00 from subsequent fiscal year.

An additional Four Hundred Dollars and No Cents (\$400.00) per client, per day for 1:1 individual care, not to exceed One Thousand Three Hundred Dollars and No Cents (\$1,300.00) per client, per day for Indigent and Medi-Cal patients. All such services are to be coordinated with County and prior approval shall be obtained from the Siskiyou County Health and Human Services Agency Director, Behavioral Health Division Director, or his or her designee."

All other terms and conditions of the Contract for Services shall remain in full force and effect.
