

**ADDENDUM TO CONTRACT FOR SERVICES
BY INDEPENDENT CONTRACTOR**

THIS 2nd ADDENDUM is to that Contract for Services entered into on October 7, 2014 by and between the County of Siskiyou ("County") and Restpadd Psychiatric Health Facility ("Contractor") and is entered into this 9th day of June, 2015.

WHEREAS, the Contract expires on June 30, 2015 and services continue to be required after that date; and

WHEREAS, the parties desire to extend the term of the Contract; and

WHEREAS, the parties desire to update the rates in Exhibit A, Section 2. Compensation and Billing: A, 1; and

WHEREAS, the parties desire to update the web link in Paragraph 5.19 C and Exhibit A, Section 4. Compliance.

NOW, THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Article 1, Paragraph 1.01 Contract Term shall be amended to extend the term of the contract through June 30, 2020.

Exhibit A, Section 2: Compensation and Billing, A, 1: to amend the rates as follows:

Fiscal Year 15/16

Eight Hundred Forty Dollars and No Cents (\$840.00) per client, per day for Indigent and Medi-Cal patients. Contractor will not charge for the client's day of discharge. An increase of \$20.00 from previous fiscal year.

Fiscal Year 16/17


Eight Hundred Sixty Dollars and No Cents (\$860.00) per client, per day for Indigent and Medi-Cal patients. Contractor will not charge for the client's day of discharge. An increase of \$20.00 from subsequent fiscal year.
