**FIRST ADDENDUM TO CONTRACT FOR SERVICES  
 BY INDEPENDENT CONTRACTOR**

This FIRST ADDENDUM is to that Contract executed on August 11, 2015 by and between the County of Siskiyou (County) and Charis Youth Center (Contractor).

WHEREAS, the parties desire to amend the rates in Exhibit A, Paragraph 2.A, COMPENSATION AND BILLING; and

WHEREAS, the parties desire to make verbiage changes in Exhibit A, Paragraph 1.1.1, Paragraph 2.C, and Paragraph 3.7;

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

I. Paragraph 1.1.1 of Exhibit A shall be amended to read "All referrals to the adolescent residential program must be processed through and approved by Siskiyou County Health and Human Services Agency Behavioral Health Division."

II. Paragraph 2.A of Exhibit A shall be amended to read as follows:

"PAYMENT: Effective July 1, 2016, County shall pay Contractor at the following rates:

Crisis Intervention	\$4.00 per staff minute
Case Management	\$2.08 per staff minute
Medication Support	\$4.96 per staff minute
Therapeutic 1:1	\$30.00 per hour
Rehabilitation Individual/Group	\$2.69 per staff minute
MHS (Collateral/Assessment, Plan Development, TBS/BIS Psychotx Individual, Psychotx Group)	\$2.69 per staff minute
Individual/Family Therapy	\$2.69 per staff minute"

III. The first sentence of Paragraph 2.C, CONTRACT SUPERVISION, of Exhibit A shall be amended to read "The Siskiyou County Health and Human Services Agency Director, hereinafter referred to as Director, or his or her designee, shall be the county employee authorized and assigned to represent the interests of the County and to ensure that the terms and conditions of this contract are carried out."

IV. Paragraph 3.7 of Exhibit A shall be amended to read "All provisions in Paragraph 3, COST REPORT AND SETTLEMENT, shall survive the termination, expiration, or cancellation of this agreement."

All other terms and conditions of the Contract shall remain in full force and effect.


