THE BOARD OF SUPERVISORS OF THE COUNTY OF SISKIYOU ORDAINS AS
FOLLOWS:

SECTION I: Section 2-2.101, of Article 1, of Chapter 2, of Title 2 is hereby amended to read as follows:

“There shall be two (2) regular meetings of the Board of Supervisors each month, effective September 1, 2017. Except as specified in subdivision (a), the regular meetings shall be held the first and third Tuesdays of each month.

(a) In the months of July, August, November, and December, the regular meetings of the Board of Supervisors shall be held on the first two Tuesdays of the month.”

SECTION II: Constitutionality: If any section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be unconstitutional, such decision shall not affect the validity of the remaining portion of this ordinance. The Board of Supervisors hereby declares that it would have passed this ordinance and each section, subsection, sentence, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases be declared unconstitutional.

SECTION III: This ordinance shall become effective 30 days after its passage and shall, within 15 days of adoption, be published once in a newspaper of general circulation, printed and published in the County of Siskiyou.

THE BOARD OF SUPERVISORS OF THE COUNTY OF SISKIYOU ORDAINS AS
FOLLOWS:

SECTION I: Section 2-2.101, of Article 1, of Chapter 2, of Title 2 is hereby amended to read as follows:

~~“Except as specified in subdivision (a), effective April 1, 2003, there shall be three (3) two (2) regular meetings of the Board of Supervisors each month, effective September 1, 2017. Except as specified in subdivision (a), the regular meetings shall be held the first two and third Tuesdays of each month.~~

~~(a) There shall be two (2) regular meetings of the Board of Supervisors in the months of July, August, November, and December, the regular meetings of the Board of Supervisors shall be held on the first two Tuesdays of each of these the months.”~~

SECTION II: Constitutionality: If any section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be unconstitutional, such decision shall not affect the validity of the remaining portion of this ordinance. The Board of Supervisors hereby declares that it would have passed this ordinance and each section, subsection, sentence, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases be declared unconstitutional.

SECTION III: This ordinance shall become effective 30 days after its passage and shall, within 15 days of adoption, be published once in a newspaper of general circulation, printed and published in the County of Siskiyou.
