

**FIRST ADDENDUM TO CONTRACT FOR SERVICES
BY INDEPENDENT CONTRACTOR**

THIS 1st ADDENDUM is to that Contract for Services entered into on August 2, 2016 by and between the County of Siskiyou ("County") and Victor Treatment Centers, Inc. ("Contractor") and is entered into this 16th day of May, 2017.

WHEREAS, the parties desire to update Contractor's contact information; and

WHEREAS, the parties desire to update the rates in Exhibit A, Section 2. Compensation and Billing: A.

NOW, THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

The Contractor's contact information shall be amended as follows:

"8.01 Notices: Any notices to be given hereunder by either party to the other may be effected either by personal delivery in writing or by mail, registered or certified, postage prepaid or return receipt requested. Mailed notices shall be addressed to the parties at the addresses appearing in the introductory paragraph of this Contract, but each party may change the address by written notice in accordance with the paragraph. Notices delivered personally will be deemed communicated as of actual receipt; mailed notices will be deemed communicated as of two (2) days after mailing.

The rates set forth in Exhibit A, Section 2: Compensation and Billing, A, shall be amended as follows:

“A. County shall pay Contractor for services provided at the following rates:

Mental Health Services (including TBS)	\$2.61 per minute
Intensive Home Based Services	\$2.61 per minute
Intensive Care Coordination	\$2.02 per minute
Case Management Services	\$2.02 per minute
Crisis Intervention Services	\$3.88 per minute
Medication Support Services (psychiatrist only)	\$4.82 per minute
Room & Board	\$10,410 per client per month

Contractor agrees to pro-rate the monthly Room and Board rate.

Contractor within shall provide an invoice that includes a description of the services provided each month, including number of patients served, hours and types of service provided.”

All other terms and conditions of the Contract for Services shall remain in full force and effect.
