

**2nd ADDENDUM TO CONTRACT FOR SERVICES
BY INDEPENDENT CONTRACTOR**

THIS ADDENDUM is to that Contract for Services entered into on June 10, 2014 by and between the County of Siskiyou ("County") and Remi Vista, Inc. ("Contractor") and is entered into this 14th day of July, 2015.

WHEREAS, the Contract expires on June 30, 2015 and services continue to be required after that date; and

WHEREAS, the parties desire to extend the term of the Contract; and

WHEREAS, the parties would like to increase the not to exceed limit to \$750,000, and

WHEREAS, the parties desire to update the web link in the Contract for Services; and

WHEREAS, the parties desire to incorporate additional service under the Scope of Service; and

WHEREAS, the parties desire to amend the rates in Compensation and Billing; and

WHEREAS, the parties desire to change the wording in Contract Amendments.

NOW, THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 1.01 of the Contract for Services shall be amended to extend the term of the contract through June 30, 2017.

Paragraph 4.01 Compensation: shall read as follows:

In consideration for services to be performed by Contractor, county agrees to pay contractor in proportion to services satisfactorily performed as a specified in Exhibit A, not to exceed SEVEN HUNDRED FIFTY THOUSAND DOLLARS AND NO CENTS (\$750,000.00).


