The Siskiyou County Board of Supervisors is looking for people to serve on the Behavioral Health Services Board.

The Behavioral Health Services Board's objectives include review and evaluation of the county's mental health services and facilities, including drug and alcohol services. This board typically meets the third Monday of each month in Yreka at 3:30p.m.; meetings usually last for two hours and are open to the public. Members are reimbursed for mileage to attend meetings and certain training expenses. Board members serve three year terms; and qualifications include being a resident of Siskiyou County, a consumer of mental health services; or a family member of a mental health services consumer; or a person who is interested in mental health issues.

To find out more about the Behavioral Health Services Board, you are encouraged to attend their meetings. The meetings are held the third Monday of each month, at 2060 Campus Drive, Yreka; beginning at 3:30 p.m. You can also contact Camy Rightmier, MSHA Coordinator at 841-4281.
