

FIRST ADDENDUM TO CONTRACT FOR SERVICES

(1ST Addendum to extend the term for the Tulelake Solid Waste/Recycling Facility
Operation Agreement)

THIS FIRST ADDENDUM is to that Contract for Services entered into on the 16th day of April 2017 by and between the County of Siskiyou ("County") and the City of Tulelake ("City") and is entered into this _____ day of _____, 2018.

WHEREAS, the Contract will expire on the 15th day of April, 2018 and services continue to be required after that date; and

WHEREAS, both parties desire to extend the term of the Contract for one additional one-year period; and

WHEREAS, the parties also desire to amend the amount payable under the contract.

NOW, THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Section 3.0 of the Operation Agreement, Term, shall be amended to extend the term of the contract through the 15th day of April, 2019 unless terminated earlier in accordance with Sections 18.0 or 19.0;

Section 15.0, of the Operation Agreement, Contract Price/Payment Procedures, shall be amended to provide that:

Paragraph A, Contract Price, shall be amended to add an additional \$8,166.66 (eight thousand one hundred sixty six dollars and sixty six cents) for FY 17/18 for a total not to exceed \$49,000 (forty nine thousand dollars) and add an additional \$40,833.34 (forty thousand eight hundred thirty three dollars and thirty four cents) for FY 18/19 for a total contract not to exceed \$98,000 (ninety eight thousand dollars). :

All other terms and conditions of the Contract for Services shall remain in full force and effect.
