

**ADDENDUM 8 TO CONTRACT FOR SERVICES
BY INDEPENDENT CONTRACTOR**

THIS ADDENDUM 8 is to that Contract executed on October 25, 2011, as amended from time to time, between the County of Siskiyou ("County") and Language Line Services, Inc. ("Contractor").

WHEREAS, the Contract expires on September 30, 2018 and services continue to be required after that date; and

WHEREAS, the parties desire to extend the term of the Contract; and

WHEREAS, the California Multiple Award Schedule (CMAS) contract number 4-07-0249A Supplement No. 2 with Language Line Services, Inc. is scheduled to expire on September 30, 2018; and

WHEREAS, Language Line Services, Inc. is in negotiations with the California Department of General Services regarding the extension of, or re-issuance of, this CMAS contract; and

WHEREAS, the cost of services to be provided under the contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the contract.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

- I. The term of the Contract will be extended to expire June 30, 2020.
- II. On the Signature Page, APPROVED AS TO ACCOUNTING FORM section of the Contract shall be amended to change the total not to exceed amount payable under the Contract by an additional amount not to exceed the sum of SIX THOUSAND AND NO/100 DOLLARS (\$6,000.00) per Fiscal Year, split between two accounting codes, and covering all of Fiscal Years 2018-19 and 2019-20, as indicated in the ACCOUNTING section below. Funding is contingent on the CMAS Contract Number 4-07-03-0249A, Supplement No. 2 termination date being extended or the Contract being reissued with a termination date of June 30, 2019 or later. The total not to exceed amount for the term of the Contract is FORTY-SEVEN THOUSAND SIX HUNDRED AND NO/100 DOLLARD (\$47,600.00).

All other terms and conditions of the Contract shall remain in full force and effect.
