

**SECOND ADDENDUM TO PROFESSIONAL
SERVICES RETENTION AGREEMENT**

THIS SECOND ADDENDUM TO PROFESSIONAL SERVICES RETENTION AGREEMENT is for that Contract for Professional Services entered into on January 31, 2018, by and between the County of Siskiyou (County) and William M. Abbott and the firm of ABBOTT & KINDERMANN, Inc., (Contractor) and is entered into this 13th day of November 2018.

WHEREAS, the cost of services to be provided under the contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the contract; and

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 3 of the Contract, Legal Fees, shall be amended to add an additional fifty thousand dollars and no/100 (\$50,000), to increase the compensation payable under the contract to an amount not to exceed ninety five thousand dollars and no/100 (\$95,000).

All other terms and conditions of the Contract shall remain in full force and effect.
