

**MEMORANDUM OF UNDERSTANDING
BETWEEN
COUNTY OF SISKIYOU
ON BEHALF OF
SISKIYOU COUNTY PROBATION DEPARTMENT
AND
NEW BEGINNINGS COUNSELING CENTERS, INC.**

THIS MEMORANDUM OF UNDERSTANDING is between the COUNTY OF SISKIYOU, a political subdivision of the State of California, on behalf of the Siskiyou County Probation (Department), and New Beginnings Counseling Centers, Inc., (Program) and it is effective upon the execution of both parties.

WHEREAS, Sex Offender Treatment Programs help promote the rehabilitation of Sex Offenders and promote a safer community by providing service;

WHEREAS, in light of the information set forth in the above recital, the Department desires to build its Sex Offender program with the hope of increasing Sex Offender Treatment to those offenders that are in need for successful rehabilitation;

WHEREAS, in an effort to begin its process, the Department desires to provide Sex Offender Treatment services to referred offenders from the Program;

WHEREAS, in furtherance of its purpose, the Program desires to assist the efforts of the Department by providing support for the assigned clinician, regular communication regarding attendance and program evaluation every six months. This will ensure that the Department builds a quality program;

NOW THEREFORE IT IS AGREED as follows:

1. New Beginnings Counseling Centers, Inc. shall reimburse the Department in the sum of \$65 per hour for each hour of sex offender services completed and verified as per the Sex Offender Treatment Contract. Services shall include facilitated groups, individual sessions, assessments and required documentation. The county will provide quarterly invoices that are to be paid within 30 days.
2. If at any time the Department is unable to provide an individual to perform Sex Offender Treatment Services, New Beginnings Counseling Centers, Inc. and the Department shall, in a timely manner, meet to determine an acceptable alternative to this requirement.
3. The Department will maintain appropriate records regarding Sex Offender Treatment Services.
4. The Department shall perform all Sex Offender Treatment Services in accordance with the applicable provisions of the California Penal Code and all best mental health practices. Services shall include treatment groups, individual sessions, assessments and required documentation.

5. New Beginnings Counseling Centers, Inc., shall hold harmless, defend and indemnify Siskiyou County and its officers, officials, employees and volunteers from and against any and all liability, loss, damage, expense, costs (including without limitation costs and fees of litigation) of every nature arising out of or in connection with New Beginnings Counseling Centers, Inc. performance of work hereunder or its failure to comply with any of its obligations contained in the agreement, except such loss or damage which was caused by the sole negligence or willful misconduct of the Siskiyou County.
6. This Memorandum of Understanding shall remain in full force and effect from January 1, 2019, through December 31, 2019, at which time it shall automatically expire and be of no further force or effect.

IN WITNESS WHEREOF, we affix our signature to this Memorandum of Understanding as the full and complete understanding of the relationship between the parties hereto.


