

**ADDENDUM TO CONTRACT FOR SERVICES
BY INDEPENDENT CONTRACTOR**

THIS SECOND ADDENDUM is to that Contract executed on February 6, 2018, and amended on October 20, 2018, between the County of Siskiyou (County) and SWCA, Incorporated, dba SWCA Environmental Consultants (Contractor).

WHEREAS, the cost of services to be provided under the contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to add certain language to the contract clarifying the County's need for original receipts; and

WHEREAS, the parties desire to increase the amount of compensation payable under the contract; and

WHEREAS, the parties desire to incorporate the Contractor's current labor rates into the contract.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 3 of the Contract, Exhibit A, shall be replaced in its entirety to reflect a not-to exceed value of \$250,000.

Exhibit "B", entitled "Exhibit B- SWCA Project Rate Sheet", shall become Exhibit "B-1" and shall be retitled as "Exhibit B-1: SWCA 2018 Rate Sheet".

An "Exhibit B-2", entitled "Exhibit B-2: SWCA 2019 Rate Sheet- Effective August 6, 2019", which is attached hereto and hereby incorporated by reference, shall be added to the contract following Exhibit "B-1".

Section 4.02 of the contract, shall be amended to read as follows: "Invoices: Contractor shall submit detailed invoices for all services being rendered including original itemized receipts".

Section 4.01 of the Contract, entitled "Compensation", shall be amended to add an additional fifty thousand dollars (\$50,000) of compensation, increasing the compensation payable under the contract to an amount not to exceed two-hundred and fifty thousand dollars (\$250,000) for the term of the contract.

All other terms and conditions of the Contract shall remain in full force and effect.

IN WITNESS WHEREOF, County and Contractor have executed this addendum on the dates set forth below, each signatory represents that he/she has the authority to

execute this agreement and to bind the Party on whose behalf his/her execution is made.
