

**MASTER SERVICES AGREEMENT
ADDENDUM NUMBER 2**

This Addendum, entered into the 14 of AUGUST, 2020, between the County of Siskiyou, a legal and political subdivision of the State of California of the one part, hereinafter "County" or "Customer," and Pay Tel Communications, Inc. of the other part, hereinafter "Pay Tel" or "Contractor" modifies the Inmate Telecommunications Agreement dated September 17, 2013 as amended by Addendum 1 dated September 18, 2018 (hereafter collectively referred to as the "Agreement").

For and in consideration of the mutual promised and covenants contained herein, Pay Tel and Customer hereby agree to modify the Agreement as follows:

1. **6.0 Equipment and Services Provided by Pay Tel.** This section is hereby expanded to provide for the provision of 1 additional inmate video visitation kiosk. In addition, upon installation of this kiosk, remote video visits with the Public Defender will be provided at no charge to either party. Pay Tel will arrange for delivery of the new kiosk to County, and County will be responsible for any necessary wiring and installation with remote support by Pay Tel.

2. **Attachment B: Video Visitation Revenue Share.** Effective the first full month following execution of this Addendum, the commission paid to County for remote video visitation revenue shall be reduced to 20%.

Except as written above, all other portions of the Agreement shall remain unchanged.
