SECOND ADDENDUM TO CONTRACT FOR SERVICES BY INDEPENDENT CONTRACTOR

THIS SECOND ADDENDUM is to that Contract for Services entered into on July 14, 2020 and as amended on April 6, 2021 by and between the County of Siskiyou ("County") and Siskiyou Child Care Council ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the Contract expired on June 30, 2021 and services continued to be required after that date; and

WHEREAS, the parties desire to extend the term of the Contract;

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 1.01 of the Contract for Services shall be amended to extend the term of the Contract through August 31, 2021.

Paragraph 4.01 of the Contract, Compensation, shall be amended to add an additional TWENTY-FIVE THOUSAND and NO/100 DOLLARS (\$25,000.00) for child care reimbursement for the Fiscal Year 21/22, to increase the total compensation payable under the Contract to an amount not to exceed ONE HUNDRED-EIGHTY-FIVE THOUSAND and NO/100 DOLLARS (\$185,000.00) for the term of the Contract; and

Paragraph 4.01 of the Contract, Compensation, Exhibit "A1", shall be deleted and replaced in its entirety with the new Exhibit "A1", Budget, attached hereto and hereby incorporated by reference.

All other terms and conditions of the Contract shall remain in full force and effect.
