

**THIRD ADDENDUM TO CONTRACT FOR SERVICES
BY INDEPENDENT CONTRACTOR**

THIS THIRD ADDENDUM is to that Contract for Services entered into on July 3, 2018 and as amended on June 4, 2019 and amended on June 16, 2020 by and between the County of Siskiyou ("County") and Oil Re-Refining Company (ORRCO)("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the Contract expired on June 30, 2021 and services continued to be required after that date; and

WHEREAS, the parties desire to extend the term of the Contract;

WHEREAS, the Scope of Services, Exhibit "A", needs to be replaced.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 1.01 of the Contract for Services shall be amended to extend the term of the Contract through June 30, 2026.

Paragraph 3.01 of the Contract for Services, Exhibit "A", shall be deleted and replace in its entirety with the new Exhibit "A", attached hereto and hereby incorporated by reference.

All other terms and conditions of the Contract shall remain in full force and effect.
