ADDENDUM TO CONTRACT FOR SERVICES BY INDEPENDENT CONTRACTOR

THIS FOURTH ADDENDUM is to that Contract executed on February 6, 2018, and amended on October 20, 2018, August 6, 2019, and January 28, 2021, between the County of Siskiyou (County) and SWCA Environmental Consultants (Contractor).

WHEREAS, the Contract expired on June 30, 2021, and services continue to be required after that date; and,

WHEREAS, the cost of services to be provided under the contract is expected to exceed the amount provided in the Contract; and,

WHEREAS, the parties desire to extend the term of the Contract; and,

WHEREAS, the parties desire to increase the amount of compensation payable under the contract; and,

WHEREAS, the parties desire to incorporate the Contractor's current labor rates into the contract.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

- 1. Paragraph 1.01 of the Contract for Services shall be amended to extend the term of the contract through June 30, 2022.
- Paragraph 4.01 of the Contract shall be amended to clarify the section and to increase compensation under the Contract by fifty-thousand dollars (\$50,000.00), and shall read as follows:
 - 4.01 <u>Compensation</u>: In consideration for the services to be performed by Contractor, County agrees to pay Contractor in proportion to services satisfactorily performed as specified in Exhibit "A" at the rates set forth in Exhibits "B" the not to exceed amount of Three Hundred Thousand Dollars (\$300,000.00) for the term of the Contract.
- 3. The Exhibit "B-3" that is attached hereto and incorporated herein shall be appended to the Contract behind Exhibit "B-2". The rates set forth in Exhibit "B-3" shall become effective on July 13, 2021.
- 4. All other terms and conditions of the Contract shall remain in full force and effect.
