NOTICE IS HEREBY GIVEN that PacifiCorp, an Oregon corporation, has filed an application with the County of Siskiyou requesting that the County renew its utility franchise through the grant of a franchise pursuant to the Franchise Act of 1937, to construct, maintain and use electrical lines and appurtenances for transmitting and distributing electricity for any and all lawful purposes in, along, across, upon, and under the public streets and places within the unincorporated

and places within the unincorporated area of the County of Siskiyou.
