Natural Resources - Approve addendum to contract with Larry Walker Associates, Inc., with regard to Proposition 1 grant funding for the Sustainable Groundwater Management Act, increasing contract by \$68,000 to a total not to exceed \$1,101,000.

Natural Resources - Approve contract with Larry Walker Associates, Inc., to utilize grant funding through the Bureau of Reclamation for development of Groundwater Sustainability Plans as part of the Sustainable Groundwater Management Act, in an amount not to exceed \$175,128, for the term July 1, 2020 through June 30, 2022.

Transfer of Funds - Flood Control - \$175,128. Resolution FLD 21-03 adopted.

It was moved by Director Haupt, seconded by Director Kobseff and carried, following a roll call vote with Directors Criss, Kobseff, Valenzuela, Ogren and Haupt voting YES, to adopt Resolution FLD 21-03, Transfer of Funds, Flood Control, in the amount of \$175,128.
