I am hoping that with your help I can purchase both some training tools and safety equipment to aid in keeping my team safe during operations. The money used by your foundation (if awarded) will go to buying conversion kits for our department rifles to be able to use Simunitions rounds which is used for training. The advantage Simunitions has is you can have real fire trills that are more realistic and therefore better training for my team. We often have volunteers ald us in these trainings which are often Police Academy cadets or members of the community. Additionally the funds will be used for a piece of surveillance/recon equipment called a Bouncing imaging ball which allows a team member to deploy this into area of risk with minimal risk to the team member and give us remote access to 360 degree cameras and audio which allow us to gain vital intel prior to deploying my team into harms way.
