The Siskiyou County Clerk announces that there are three scheduled vacancies and two unscheduled vacancies on the Siskiyou County Behavioral Health Services Board, for four Member positions and one Alternate member position. Board members serve three year terms; and qualifications include being a resident of Siskiyou County, as consumer of mental health services, or a family members of a mental health services consumer; or a person who is interested in mental health issues.
