THIRD ADDENDUM TO CONTRACT FOR SERVICES BY INDEPENDENT CONTRACTOR

THIS THIRD ADDENDUM is to that Contract for Services entered into on October 1, 2019 and as amended on July 14, 2020 and March 17, 2021 by and between the County of Siskiyou ("County") and Personnel Preference, Inc. ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the Contract expires on December 31, 2021 and services continued to be required after that date; and

WHEREAS, the parties desire to extend the term of the Contract;

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 1 of the Contract for Services shall be amended to extend the term of the Contract through June 30, 2022; and

Paragraph 4.01 of the Contract, Compensation, shall be amended to add an additional SEVENTY-EIGHT THOUSAND AND NO/100 DOLLARS (\$78,000.00), to increase the compensation payable under the Contract to an amount not to exceed TWO HUNDRED FIFTY-FIVE THOUSAND, ONE HUNDRED EIGHTY-NINE AND NO/100 DOLLARS (\$255,189.00); and

Paragraph 4.02 of the Contract, Compensation Dependent on Budget, shall be amended to include Exhibit A1 (i) and A1 (j) attached hereto.

All other terms and conditions of the Contract shall remain in full force and effect.
