

**SECOND ADDENDUM TO CONTRACT FOR SERVICES
BY INDEPENDENT CONTRACTOR**

THIS SECOND ADDENDUM is to that Contract for Services entered into on July 14, 2020 and as amended on the same day, between the County of Siskiyou ("County") and Ray Morgan Company ("Contractor") and is entered into on the date signed by all parties to it.

WHEREAS, County of Siskiyou, Probation Department, is in need of an additional multipurpose printer; AND

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract.

NOW, THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

The section of the Agreement under EQUIPMENT DESCRIPTION, shall be amended to add an additional Canon ImageRUNNER ADVANCE DX C257IF

The section of the Agreement under TERM AND PAYMENT SCHEDULE shall be amended to add an additional One Hundred Forty-Five and 18/100 Dollars (\$145.18) per month to increase the compensation payable under the Contract to an amount not to exceed Three Hundred Twenty-Two and 38/100 Dollars amount (\$322.38) per month for 41 months.

All other terms and conditions of the Contract for Services shall remain in full force and effect.
