The Siskiyou County Sheriff's Office is responsible to enforce Federal, State, and local laws regarding boating operations within Siskiyou County. Water Safety Deputies routinely provide boat inspections and are responsible for issuing warnings and citations, and effecting arrests for violations on our numerous lakes and rivers. In addition, the Siskiyou County Sheriff's Office maintains a highly-active Dive Recovery Team, Swift Water Rescue Team and Search and Rescue program which utilizes boats during recovery and search operations.
