## Airport Land Use Commission Minutes

### February 1, 2022

The Honorable Commissioners of the Airport Land Use Commission of Siskiyou County, California, met in regular session this 1<sup>st</sup> day of February 2022; there being present Directors Nancy Ogren, Ray A. Haupt, Ed Valenzuela and Michael N. Kobseff, County Administrator Angela Davis, Commission Counsel Edward J. Kiernan, and County Clerk and ex-Officio Clerk of the Airport Land Use Commission Laura Bynum by Deputy County Clerk Wendy Winningham. Supervisor Brandon Criss participated via teleconference/ZOOM.

The meeting was called to order by Vice Chair Valenzuela.

#### Public Comment

There were no public comments received.

**Public Hearings –** Community Development - Planning Division - Public hearing to consider adopting a Resolution determining the project not subject to the California Environmental Quality Act (CEQA) and determining the zone change ordinance (Z-21-07) consistent with the Siskiyou County Airport Land Use Compatibility Plan, for the Purvis Zone Change (Z-21-07). Resolution ALUC 22-01 adopted.

This was the time set for a public hearing to consider adopting a Resolution determining the project not subject to the California Environmental Quality Act (CEQA) and determining the zone change ordinance (Z-21-07) consistent with the Siskiyou County Airport Land Use Compatibility Plan, for the Purvis Zone Change (Z-21-07).

The Vice Chair opened the public hearing.

Senior Planner Rachel Jereb provided an overview of the request, advising that the Purvis Zone Change Project property was with Zone B of the Siskiyou County Airport Land Use Compatibility Plan and requested that the Airport Land Use Commission determine that the Project is consistent with the Compatibility Plan and not subject to the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15060(c)(3).

In response to Vice Chair Valenzuela, Deputy County Clerk Wendy Winningham advised that the Clerk's Office had not received correspondence related to this item.

There being no public comments received, the public hearing was declared closed.

It was moved by Commissioner Haupt, seconded by Commissioner Valenzuela and carried, following a roll call vote with Commissioners Haupt, Kobseff, Ogren, Valenzuela and Criss voting YES, to adopt the proposed resolution, A Resolution of the Airport Land Use Commission of the County of Siskiyou, State of California, No. ALUC 22-01 Determining the Project Not Subject to the California Environmental Quality Act (CEQA) and Determining the Zone Change Ordinance (Z-21-07) Consistent with the Siskiyou County Airport Land Use Compatibility Plan.

**Adjournment** - There being no further business to come before the Airport Land Use Commission, the meeting was adjourned.
