

**THIRD ADDENDUM TO CONTRACT FOR SERVICES  
BY INDEPENDENT CONTRACTOR**

THIS THIRD ADDENDUM is to that Contract for Services entered into on April 2, 2019 and as amended on October 6, 2020 by and between the County of Siskiyou ("County") and Executive Information Services, Inc. (EIS) ("Contractor") and is entered into this 28<sup>th</sup> day of October 2021.

WHEREAS, the Contract expires on December 31, 2021 and services continued to be required after that date; and

WHEREAS, the parties desire to extend the term of the Contract;

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 1.01 of the Contract for Services shall be amended to extend the term of the Contract through December 31, 2023.

Paragraph 4.01 of the Contract, Compensation, shall be amended to add an additional Forty Six Thousand Seven Hundred Eighty Dollars and no cent (\$46,780.00) for FY 21/22 and Forty Nine Thousand One Hundred Twenty Dollars and no cents (\$49,120.00) for FY 22/23 to increase the compensation payable under the Contract to an amount not to exceed Two Hundred Sixteen Thousand Ninety Dollars and Twenty Seven cents (\$216,090.27).

All other terms and conditions of the Contract shall remain in full force and effect.

IN WITNESS WHEREOF, County and Contractor have executed this Third Addendum on the dates set forth below, each signatory represents that he/she has the authority to execute this agreement and to bind the Party on whose behalf his/her execution is made.
