Notice of Public Hearing

The Siskiyou County Board of Supervisors will hold a public hearing on April 19, 2022 at 9:00a.m., or as soon thereafter as may be heard, in the Board of Supervisors Chambers, 311 Fourth Street, Yreka, CA, on the following item:

Manley Agricultural Preserve Amendment and Williamson Act Contract Rescission and Reentry (APA2101)

The project is a proposal to rescind the current Williamson Act contracts with subsequent re-entry, while simultaneously amending the existing agricultural preserves in order to facilitate a proposed boundary line adjustment. The project site is located at 3315 and 3625 East State Highway 3, approximately one mile west of the Town of Montague on APNs 013-280-180, 013-310-030, -150, 013-320-080, -270, 013-400-010, -190, 013-440-020, 052-360-090, and 052-341-140; Sections 20, 28, and 29 Township 45N, Range 6W, MDB&M (Latitude 41°43'35"N, Longitude 122°33'31"W).

It is anticipated that the proposed agricultural preserve and Williamson Act contract amendments will be determined to be categorically exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15317, Open Space Contracts or Easements. A categorical exemption implies that a project will not result in any significant adverse environmental effects. The Board of Supervisors will consider the appropriateness of said environmental recommendation based on the record of evidence before them. If substantial evidence has been presented demonstrating a more appropriate environmental determination than the one that has been recommended, the Board of Supervisors may require and/or approve an alternative environmental determination pursuant to the requirements of CEQA.

The public may attend by ZOOM/teleconference, but it is unknown at this time whether the public hearing will be held via ZOOM/teleconference only. This decision will be made based upon COVID 19 infection rates as the meeting date approaches and will be set forth on the meeting agenda posted both online and physically the Friday before the meeting.

If the public is allowed to attend, all interested persons are invited to be present and be heard thereon or present comments in writing to the Board of Supervisors, 311 Fourth Street, Room 201, Yreka, CA 96097. All items presented to the Board of Supervisors during a public hearing, including but not limited to, letters, email, petitions, photos, or maps, become a permanent part of the record and must be submitted to the Clerk of the Board. It is advised that the presenter bring 7 copies of anything presented to the Board and that the presenter create copies in advance for their own records.

All project documents are on file at the Planning Division of the Siskiyou County Community Development Department and are available for public review. A staff report will be available for public review three working days prior to the Board of Supervisors meeting. All supporting documentation is available for public review in the office of the Clerk of the Board of Supervisors, located in the Siskiyou County Clerk's Office, Yreka, CA 96097, during regular business hours, 9:00 a.m. – 12:00 p.m. and 1:00 p.m. - 4:00 p.m., Monday through Friday.

If you challenge the categorical exemption and/or zone change in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Board of Supervisors prior to or at the public hearing.
