

**FIRST ADDENDUM TO CONTRACT FOR SERVICES
BY INDEPENDENT CONTRACTOR**

THIS FIRST ADDENDUM is to that Contract for Services entered into on July 1, 2021 by and between the Siskiyou Power Authority ("County") and Absher & Associates ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract; and

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 4.01 of the Contract, Compensation, shall be amended to add an additional Ten Thousand Nine Hundred Thirty-Seven Dollars and 50/100 (\$10,937.50) to Fiscal Year 21/22. Each additional Fiscal Year (22/23, 23/24, 24/25) shall remain at a not to exceed Ten Thousand Eight Hundred Dollars and no/100 (\$10,800.00) per Fiscal Year. To increase the total compensation payable under the Contract to an amount not to exceed Fifty-Four Thousand One Hundred Thirty-Seven and 50/100 (\$54,137.50) for the term of the Contract.

All other terms and conditions of the Contract shall remain in full force and effect.
