

**FIRST ADDENDUM TO CONTRACT FOR SERVICES
BY INDEPENDENT CONTRACTOR**

THIS FIRST ADDENDUM is to that Contract for Services entered into on August 11, 2020 by and between the County of Siskiyou ("County") and Jones Carpet Cleaning and Janitorial ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract; and

WHEREAS, the Scope of Service, Exhibit A, needs to be revised to reflect additional duties.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 2 of the Contract, Services to be Performed, Exhibit "A", shall be deleted and replaced in its entirety with the new Exhibit "A", Scope of Services, attached hereto and hereby incorporated by reference.

Paragraph 4 of the Contract, Compensation, shall be amended to add an additional SEVEN THOUSAND FIVE HUNDRED AND NO/DOLLARS (\$7,500.00), to increase the compensation payable under the Contract to an amount not to exceed FOUR HUNDRED FORTY NINE THOUSAND, THREE HUNDRED SIXTY-FOUR AND NO/DOLLARS (\$449,364.00) for the term of the Contract.

All other terms and conditions of the Contract shall remain in full force and effect.




