SECOND ADDENDUM TO CONTRACT FOR SERVICES BY INDEPENDENT CONTRACTOR

THIS SECOND ADDENDUM is to that Contract for Services entered into on June 30, 2021, by and between the County of Siskiyou ("County") and Avenu Insights and Analytics, LLC ("Contractor"), and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract; and

WHEREAS, the Scope of Service, Exhibit A, needs to be revised to reflect additional duties.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 4.01 of the Contract, Compensation, shall be amended to add an additional ninety-four thousand dollars (\$94,000.00) for fiscal year 2022/2023 and ninety-four thousand dollars (\$94,000.00) for fiscal year 2023/2024, to increase the compensation payable under the Contract to an amount not to exceed two-million, five-hundred and eighty-five thousand, seventy-three dollars, and fourteen cents (\$2,585,073.14).

Paragraph 3.01 of the Contract, Scope of Services, Exhibit "A", shall be deleted and replaced in its entirety with the new Exhibit "A", Scope of Services, attached hereto and hereby incorporated by reference.

All other terms and conditions of the Contract shall remain in full force and effect.
