This correspondence is trying to summarize our operation. We own and operate the Willow Creek Ranch located about 18 miles East and slightly South of Dorris. The books on local history refer to the ranch as "The Van Brimmer Ranch", which played a significant role during the Modoc War.

It is difficult to answer some of the questions presented to me regarding the number of cattle grazed in specific areas as we have felt the effects of the ongoing drought extensively. Historically this ranch has been known to have multiple lush green meadows fed by Willow Springs along with smaller springs and bogs that flow in a manner that creates Willow Creek. The records we possess of the ranch begin with diaries of campers who traversed the Yreka Trail which runs the length of the ranch. The ranch has always been irrigated by gravity flow irrigation from the water running out of the many springs. We began seeing the change in the springs as far back as 2000. Bogs and springs began to slow and dry up. In 2015 we were shocked to see the main source of water, Willow Springs had dried completely up. There is no record of this happening from 1851 forward. As a result during the last 20 years we have had to cut our cattle numbers greatly. Our income is derived from grazing so consequently we've had a great loss of income, but we are hanging on hoping either a return to normal water flow or possibly drilling an irrigation well.

We lease the 200 acres of ground that are still irrigatible to Duane Martin Jr. Livestock. We have done this for roughly 20 years. In the 1990s we were able to graze 1000 yearlings on the meadows during the feed season (May to Oct.1), now we are grazing less than 600, and the past few years they've had to leave in August. Duane puts in about 165 pair from Sept 1 to Oct. 1 to finish off the grass on the meadow. Until the 1990s we were able to rent the meadows out in the fall to graze another 450 cows until the snow came, obviously we haven't been able to do that for many years.

Our personal cattle we keep limited between 100 to 150 pair. Depending on the feed we also keep yearling calves of our own. We raise a type of cattle that come from Arizona which are bred to browse (eat undesirable feed). This choice has kept us in business during the drought years. Our cattle are ran on the unirrigated land. They are rotated according to the feed availability. Generally the more remote areas of the deeded ground until the fall months where they are brought in closer to facilities to wean and process. The cattle are the breed called Barzona. They hunt the forage they need. Rough county and steep hills are not a deterrant to these cows.

When it becomes necessary to feed hay, we anticipate feeding 35 lbs a day per cow and 65 lbs a day per bull. Additional hay will be fed to weaned calves (30 lbs/day) and yearlings. Since hay is at a premium (\$350/ton) and freight has increased to get the hay here, we try to keep the cattle out of the hay stack as long as possible.

The parcels we are wishing to add into the Williamson Act we use for grazing. There are no plans to further develop them. The 160 acre parcel was planted with crested wheat. The parcels that were kicked out of the Williamson Act have been used for grazing since their initial land patents were issued.
