

## Notice of Public Hearing

Notice is hereby given that the Siskiyou County Board of Supervisors will hold a Public Hearing on Tuesday, June 14, 2022, at 9:00 a.m. or as soon thereafter as may be heard, in the Board of Supervisors' Chambers, Courthouse, 311 Fourth Street, Yreka, California, on the following item:

### **Matthew & Audrey Parsons Trust Agricultural Preserve Amendment and Williamson Act Contract Rescission and Reentry (APA-22-02)**

Proposed amendments to two agricultural preserves and rescission of a portion of two Williamson Act contracts with subsequent re-entry in order to consolidate all of their property under one preserve and one contract. The project site is located at 12524 Red Rock Road, approximately nine miles east of the community of Macdoel on APNs 010-010-550, 010-010-630, 010-010-660 and 002-170-270; Sections 2, 3 and 35, Township 45N & 46N, Range 1E, MDB&M (Latitude 41°46'13"N, Longitude 121°49'77"W).

It is anticipated that the proposed agricultural preserve and Williamson Act contract amendments will be determined to be categorically exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15317, Open Space Contracts or Easements. A categorical exemption implies that a project will not result in any significant adverse environmental effects. The Board of Supervisors will consider the appropriateness of said environmental recommendation based on the record of evidence before them. If substantial evidence is presented demonstrating a more appropriate environmental determination than the one being recommended, the Board of Supervisors may require and/or approve an alternative environmental determination pursuant to the requirements of CEQA.

All publications are on file in the Planning Division office for public review and a staff report will be available at the Planning Division office three working days prior to the Board of Supervisors' meeting. The public may attend by zoom/teleconference or in person. All items presented to the Board of Supervisors during a public hearing, including but not limited to, letters, e-mail, petitions, photos, or maps, become a permanent part of the record and must be submitted to the Clerk of the Board. It is advised that the presenter bring 7 copies of anything presented to the Board and that the presenter create copies in advance for their own records.

All public records related to an open session item on the agenda, which are not exempt from disclosure pursuant to the California Public Records Act, that are distributed to a majority of the legislative body will be available for public inspection at 311 Fourth Street, Room 201, Yreka CA 96097 at the same time that the public records are distributed or made available to **a majority of** the members of the legislative body. All supporting documentation is available for public review in the office of the Clerk of the Board of Supervisors, located in the Siskiyou County Clerk's Office, 311 Fourth Street, Room 201, Yreka, CA 96097, during regular business hours, 9:00 a.m. – 12:00 p.m. and 1:00 p.m. - 4:00 p.m., Monday through Friday.

If you challenge the agricultural preserve and/or Williamson Act contract in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Board of Supervisors at, or prior to, the public hearing.
