FIRST ADDENDUM TO CONTRACT FOR SERVICES BY INDEPENDENT CONTRACTOR

THIS FIRST ADDENDUM is to that Contract for Services entered into on May 21, 2019 by and between the County of Siskiyou ("County") and Prevent Child Abuse America/Healthy Families America a 501 (c) 3 Corporation ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the Contract is set to expire on December 31, 2024, and services will be required after that date; and

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract; and

WHEREAS, the Scope of Service, Exhibit A, needs to be revised to reflect additional duties.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 1.01 of the Contract for Services shall be amended to extend the term of the Contract through March 31, 2025.

Paragraph 3.01 of the Contract, Scope of Services, Exhibit "A", shall be deleted and replaced in its entirety with the new Exhibit "A", Scope of Services, attached hereto and hereby incorporated by reference.

Paragraph 4.01 of the Contract, Compensation, shall be amended to add an additional Eleven Thousand Eight Hundred Twenty Dollars and No/100 (\$11,820.00), to increase the compensation payable under the Contract to an amount not to exceed Forty Two Thousand Eight Hundred Seventy Five Dollars and No/100 (\$42,875.00) for the term of the Contract.

All other terms and conditions of the Contract shall remain in full force and effect.
