

**FIRST ADDENDUM TO CONTRACT FOR SERVICES
BY INDEPENDENT CONTRACTOR**

THIS FIRST ADDENDUM is to that Contract for Services entered into on December 13, 2017, by and between the County of Siskiyou ("County") and Relias Learning LLC ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the Contract expires on November 30, 2022, and services continued to be required after that date; and

WHEREAS, the parties desire to extend the term of the Contract;

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 10.2 "Subscription Services Term" of the Contract for Services shall be amended to extend the term of the Contract through November 30, 2027.

The Ordering Document on page 2 of the Master Agreement, and referenced throughout, shall be deleted and replaced in its entirety with the Ordering Document attached hereto and hereby incorporated by reference.

Compensation on the signature page of the Master Agreement shall be amended to add an additional SIXTY-FIVE THOUSAND SIX HUNDRED TWENTY-ONE DOLLARS AND 48/100 (\$65,621.48), to increase the compensation payable under the Contract to an amount not to exceed ONE HUNDRED TWENTY-ONE THOUSAND, SEVEN HUNDRED FORTY-FIVE DOLLARS AND 73/100 (\$121,745.73).

All other terms and conditions of the Contract shall remain in full force and effect.
