FIRST ADDENDUM TO CONTRACT FOR SERVICES BY INDEPENDENT CONTRACTOR

THIS FIRST ADDENDUM is to that Contract for Services entered into on July 15, 2022, by and between the County of Siskiyou ("County") and California Health Collaborative Corporation ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the Contract expires on January 31, 2023, and services continue to be required after that date; and

WHEREAS, the parties desire to extend the term of the Contract;

WHEREAS, the Scope of Services, Exhibit A, needs to be replaced in its entirety.

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 1.01 of the Contract for Services shall be amended to extend the term of the Contract through January 31, 2025.

Paragraph 3.01 of the Contract, Scope of Services, shall be deleted and replaced in its entirety with the new Exhibit "A", Scope of Services, attached hereto and hereby incorporated by reference.

Paragraph 4.01 of the Contract, Compensation, shall be amended to add an additional One Hundred Sixty Nine Thousand Dollars and No/100 (\$169,000.00), to increase the compensation payable under the Contract to an amount not to exceed Two Hundred Eleven Thousand Two Hundred Fifty Dollars and No/100 (\$211,250.00).

All other terms and conditions of the Contract shall remain in full force and effect.
