## **Notice of Public Hearing**

The Siskiyou County Board of Supervisors will hold a Public Hearing on Tuesday, February 7, 2023, at 9:00 a.m., in the Board of Supervisors' Chambers, Siskiyou County Courthouse, 311 Fourth Street, Yreka, California on the following item:

## Acord Williamson Act Contract Rescission and Reentry (APA2216)

The project proposes to rescind 511 acres from the current Williamson Act contract with subsequent re-entry in order to bring all property under one individual Williamson Act Contract. The proposed commercial agricultural use would remain livestock grazing. The project site is located on Ball Mountain Little Shasta Road, north and east of the city of Montague, on APNs 011-010-150, 011-020-170 and 011-040-090, Township 45N, Range 4W, Sections 9, 10 and 15, MDB&M (Latitude 41.757°, Longitude 122.305°).

It is anticipated that the proposed Williamson Act contract amendment will be determined to be categorically exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15317, Open Space Contracts or Easements. A "categorical exemption" certifies that the project will not result in any significant adverse environmental effect. The Board of Supervisors will consider the appropriateness of said environmental recommendation based on the record of evidence before them. If substantial evidence has been presented demonstrating a more appropriate environmental determination than the one that has been recommended, the Board of Supervisors may require and/or approve an alternative environmental determination pursuant to the requirements of CEQA.

All project documents are on file at the Planning Division of the Siskiyou County Community Development Department and are available for public review. All interested persons are invited to attend the meeting and be heard on any agenda item. In addition, a staff report, and all attachments will be available for public review three working days prior to the Board of Supervisors meeting either at the Planning Division office or online on the Siskiyou County website.

The public may attend by zoom/teleconference or in person. If you challenge the Williamson Act Contract Amendment in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Board of Supervisors at, or prior to, the public hearing.
