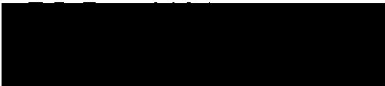

Meetings: Monthly except July and August, alternating locations between Yreka and Weed

Terms: Two years and shall vary in length (not to exceed two years) until all appointees reach a March 1 reappointment date. Terms shall be staggered, so that approximately fifty percent of each entity's appointees will come due in any given year.

Membership: The law prescribes that the council be made up of the following:
20% Consumers of child care
20% child care providers
20% public agency representatives
20% community representatives,
Remaining 20% at the discretion of appointing agencies.

50% appointed by Board of Supervisors - 50% appointed by Superintendent of Schools.

This listing only includes members appointed by the County. Seven additional members are appointed by Superintendent of Schools, for a maximum of 15 members.

Established January 20, 1998 as mandated by the Welfare Reform Bill (AB 1542) and California Education Code Chapter 2.3.
