

**FIRST ADDENDUM TO MEDICAL PROFESSIONAL SERVICES CONTRACT  
BY INDEPENDENT CONTRACTOR**

THIS FIRST ADDENDUM is to that Contract for Services entered into on October 1, 2022, by and between the County of Siskiyou (“County”) and Catherine Olivolo, Sole Proprietor (“Contractor”) and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the Contract expires on June 30, 2023, and services continue to be required after that date, and

WHEREAS, the parties desire to extend the term of the Contract;

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract; and

WHEREAS, the Scope of Services, Exhibit A, needs to be revised to reflect additional compensation.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 1.01 of the Contract for Services, Term, shall be amended to extend the term of the Contract through June 30, 2026.

Paragraph 3.01 of the Contract for Services, Scope of Services, shall be deleted and replaced in its entirety with the new Exhibit “A”, Scope of Services, attached hereto and hereby incorporated by reference.

Paragraph 4.01 of the Contract for Services, Compensation, shall be amended to add an additional Fifty Thousand Dollars and no/cents (\$50,000.00) for FY 23/24, Fifty Thousand Dollars and no/cents (\$50,000.00) for FY 24/25, and Fifty Thousand Dollars and no/cents (\$50,000.00) for FY 25/26, to increase the compensation payable under the Contract to an amount not to exceed Two Hundred Thousand Dollars and no/cents (\$200,000.00) for the term of the Contract.

All other terms and conditions of the Contract shall remain in full force and effect.

IN WITNESS WHEREOF, County and Contractor have executed this First addendum on the dates set forth below, each signatory represents that they have the authority to execute this agreement and to bind the Party on whose behalf their execution is made.
