## 2nd ADDENDUM TO CONTRACT FOR SERVICES BY INDEPENDENT CONTRACTOR

THIS 2nd ADDENDUM is to that Contract for Services entered into on January 19,2021 and as amended on March 17,2022 by and between the County of Siskiyou ("County") and Lynn Cottier ("Contractor") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the Contract expired on June 30,2023 and services continued to be required after that date; and

WHEREAS, the parties desire to extend the term of the Contract;

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 5 of the Contract for Services shall be amended to extend the term of the Contract through June 30,2025.

Paragraph 4A of the Contract, Compensation, shall be amended to add an additional Twenty Thousand and 00/100 (\$20,000.00) for fiscal year 23/24 and Twenty Thousand and 00/100 (\$20,000) for fiscal year 24/25, to increase the compensation payable under the Contract to an amount not to exceed One Hundred and Five Thousand and 00/100 (\$105,000).

Further, compensation shall be increased to the hourly rate of one-hundred and twenty-five dollars (\$125.00) per hour, including time spent traveling to and from Red Bluff and Yreka.

All other terms and conditions of the Contract shall remain in full force and effect.
