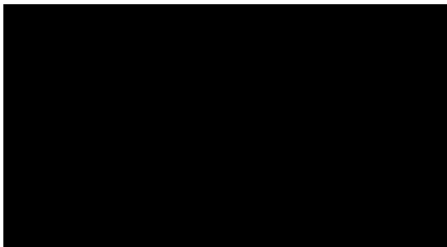

Letter of intent: I, Jack Sutcliffe send this letter of intent to fill the vacant spot on the Dunsmuir Recreation and Parks District Board.
