FIRST ADDENDUM TO MONTHLY RENTAL AGREEMENT

THIS FIRST ADDENDUM is to that Monthly Rental Agreement entered into on October 25, 2022 by and between the County of Siskiyou ("Tenant") and Edgewood Hospitality Group, Limited Liability Corporation, d.b.a. Trailer Lane Campground ("Landlord") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the cost of services to be provided under the Agreement is expected to exceed the amount provided in the Agreement; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Agreement; and

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 3 of the Agreement, Rent, shall be amended to add an additional Four Hundred Fifty Dollars (\$450.00) per month per Recreational Vehicle Space, for a total not to exceed amount of One Thousand, One Hundred Fifty Dollars (\$1,150.00) per month for each Recreational Vehicle Space beginning August 1, 2023 and ending October 31, 2023. Rent shall be prorated to Thirty-Eight Dollars (\$38.00) per day if Tenant does not occupy the Premises for the entire month of the lease.

Beginning November 1, 2023 monthly rent shall be reduced to an amount not to exceed Seven Hundred Dollars (\$700.00) per month for each Recreational Vehicle Space through the Agreement term ending, December 1, 2023.

All other terms and conditions of the Agreement shall remain in full force and effect.
