

**1st ADDENDUM TO CONTRACT FOR SERVICES
BY INDEPENDENT CONTRACTOR**

THIS 1st ADDENDUM is to that Contract for Services entered into on May 18, 2021 by and between the County of Siskiyou ("County") and Pace Engineering, Inc. ("Contractor") and is entered into on the date signed by all parties to it.

WHEREAS, the First Addendum to the Contract expires on November 30, 2021 and services continued to be required after that date; and

WHEREAS, the parties desire to extend the term of the Contract;

NOW, THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 1.01 of the Contract for Services shall be amended to extend the term of the contract through June 30, 2022.

Paragraph 3.01 of the Scope of Services shall be amended on January 1, 2022 to replace the Fee Schedule on Pages 17 and 18 in Exhibit 1 with the fee schedule effective through June 30, 2022 labeled Exhibit 1A and 1B.

All other terms and conditions of the Contract for Services shall remain in full force and effect.
