NOTICE OF ELECTION

NOTICE IS HEREBY GIVEN that the Big Springs Irrigation District will have an election on November 7, 2023 for the purpose of electing Directors to the district. Two Directors and the Treasure-Collector-Assessor are to be elected to full terms at said election ending on December 3, 2027.

Nomination papers will be available July 12, 2023 through August 7, 2023 at 7617 Machado Lane, Montague, CA 96064; phone 530-598-4013. Completed papers must be filed with the District no later than 5:00pm, on August 7, 2023. EXCEPTION: The filing period will be extended until 4:00pm on August 14, 2023, if an incumbent, eligible for reelection, fails to file a Declaration of Candidacy by 4:00pm on August 7, 2023. There is no extension of the nomination period for any office where there is no incumbent eligible to be reelected.

Appointment to each elective office will be made by the Board of Supervisors if there are no nominees or an insufficient number of nominees for the office and a petition signed by 10% of, or 50 voters, (whichever is the smaller number) has not been submitted to the Big Springs Irrigation District by August 21, 2023 requesting that an election be held.

In order to qualify for the position of Director and the Treasurer, Collector, Assessor, a person shall be a landowner within the District.


