1ST ADDENDUM TO THE MEMORANDUM OF UNDERSTANDING & AGREEMENT TO PROVIDE LAW ENFORCEMENT SERVICES

THIS FIRST ADDENDUM is to that Memorandum of Understanding (MOU) entered into on June 18th, 2019 by and between the County of Siskiyou, Office of the Sheriff ("County") and City of Montague ("City") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the MOU expired on June 30th, 2022 and services continued to be required after that date; and

WHEREAS, the parties desire to extend the term of the MOU;

WHEREAS, the cost of services to be provided under the MOU is expected to exceed the amount provided in the MOU; and

WHEREAS, the parties desire to increase the amount of compensation payable under the MOU.

WHEREAS, the County contacts listed in Section 1 and Section 2 of the MOU needs to be updated;

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

- 1. Section 4.A., page 2 of the MOU, shall be amended to extend the term of the Contract through **June 30**th, **2023**.
- 2. Exhibit A-1, Section 3, page 1, shall be amended to add fiscal year 2022-2023.
- 3. Exhibit B, Section 1, page 1, add an additional total of Two Hundred and Thirteen Thousand Two Hundred Dollars and No Cents (\$213, 200.00), increasing the total compensation payable under the MOU to an amount not to exceed Eight Hundred Fifty Two Thousand Eight Hundred Dollars and No Cents (\$852, 800.00).
