WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph <u>1.01</u> of the Contract for Services shall be amended to extend the term of the Contract through <u>June 30, 2024</u>.

Paragraph <u>4.01</u> of the Contract, Compensation, shall be amended to add an additional <u>Eighteen-Thousand-Two-Hundred Dollars</u> (\$18,200.00), to increase the compensation payable under the Contract to an amount not to exceed <u>Ninety-One-Thousand Dollars</u> (\$91,000.00).

All other terms and conditions of the Contract shall remain in full force and effect.
