Grant Request Detail

The Department has a predatory program with 2 trappers. Siskiyou County Department of Agriculture had a cooperative agreement with USDA APHIS, Wildlife Services, until about 6 years ago, when the board decided to operate a county program due to lawsuit threats regarding CEQA during a renewal of the WS contract. CDFA and WS are working on a statewide CEQA/NEPA, which should allow Siskiyou County to secure a contract with WS again.

In the interim, which has been going on for longer than expected, our Predatory program has become a county funded and run operation, without assistance from Wildlife Services, who has a mandate to provide such assistance nationwide. Our program had to scramble to adapt while continuing to provide needed services to our constituents. Procuring adequate equipment has been a challenge. As such, Dennis Moyles was given a hand me down, 90's series short wheel based 1 ton flatbed dually. 90's series ford pickups are seriously rough riding (I have one) and are taking a toll on our long term trapper. It is also a single cab, which limits the amount of equipment which can be secured in the cab. Most trappers have an extended cab for that very purpose.

I am seeking assistance in purchasing a new pickup with extended cab and a definitely much smoother riding in rough country vehicle. I have secured \$75,000 for the project which includes pickup, trailer and a side x side four wheeler, but I am approximately \$6,000 short. I am requesting consideration for supporting this program and one of my trappers needs.

The Predatory program, and its two trappers, provide direct assistance to ranchers, farmers, and residents in wildlife incidents. They have increasingly been responding to wolf depredations, being first on scene to determine cause of death or damage. In many cases, since our California Dept of Fish and Wildlife Wolf Specialist has been banned by many ranchers, our trappers are the experts depended upon to provide information that helps our ranchers request damage funds and provide recommendations on non-lethal deterrence methods (as does Wildlife Services, who does help with this without a contract). It is important for protecting ranchers, livestock and the endangered wolves in Siskiyou County, that our trappers have the ability to provide assistance where needed. Adequate equipment is a necessity.
