

FORTH ADDENDUM TO PROFESSIONAL SERVICES RETENTION AGREEMENT

THIS FORTH ADDENDUM is to that Agreement entered into on July 01, 2021, and as amended on May 20, 2022, April 4, 2023, and September 9, 2023, by and between the County of Siskiyou ("County") and The Firm of Liebert Cassidy Whitmore, ("LCW") and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the cost of services to be provided under the Agreement is expected to exceed the amount provided in the Agreement; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Agreement; and

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 3 of the Agreement, Legal Fees, shall be amended to add an additional One Hundred Twenty-Five Thousand Dollars (125,000.00), to increase the compensation payable under the Agreement to an amount not to exceed Five Hundred Seventy-Five Thousand Dollars (\$575,000.00).


All other terms and conditions of the Agreement shall remain in full force and effect.




