5th ADDENDUM TO CONTRACT FOR SERVICES BY INDEPENDENT CONTRACTOR

THIS 5th ADDENDUM is to that Contract for Services entered into on July 1, 2021, and as amended by the First Addendum on May 20, 2022; by the Second Addendum on April 4, 2023; by the Third Addendum on September 6, 2023; and by the Fourth Addendum on March 22, 2024; by and between the County of Siskiyou ("County") and The Firm of Liebert Cassidy Whitmore ("LCW"), and is entered into on the date when it has been both approved by the Board and signed by all other parties to it.

WHEREAS, the Contract expired on June 30, 2024 and services continued to be required after that date; and

WHEREAS, the parties desire to extend the term of the Contract;

WHEREAS, the cost of services to be provided under the Contract is expected to exceed the amount provided in the Contract; and

WHEREAS, the parties desire to increase the amount of compensation payable under the Contract.

NOW THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

Paragraph 2 of the Contract for Services shall be amended to extend the term of the Contract through June 30, 2025.

Paragraph 3 of the Contract, Legal Fees, shall be amended to compensate LCW in proportion to services satisfactorily performed as specified in Exhibit "A" to the Third Addendum, dated September 6, 2023. Payment shall not exceed the amount appropriated by the Board of Supervisors for such services for the fiscal year 23/24 and fiscal year 24/25.

All other terms and conditions of the Contract shall remain in full force and effect.
